These subjects may or may not be discussed in the order shown. All items listed below as part of the called "Consent Agenda Items" require no deliberation by the Court. Each Court member has the prerogative of removing an item from this agenda so that it may be considered separately.

1. PUBLIC FORUM;
2. CONSENT AGENDA ITEMS:
  - (a) Approval of Minutes of Meeting of May 12, 2008;
  - (b) Acceptance of donation by Raydon, Inc. to Precinct 2 of one (1) 1940 model, 10'x40' vessel;
  - (c) Authorization for Use of County Road Right-of-Way by Coldwater Transfer, LLC for Utility Crossing on Shawver Road – Precinct 2;
