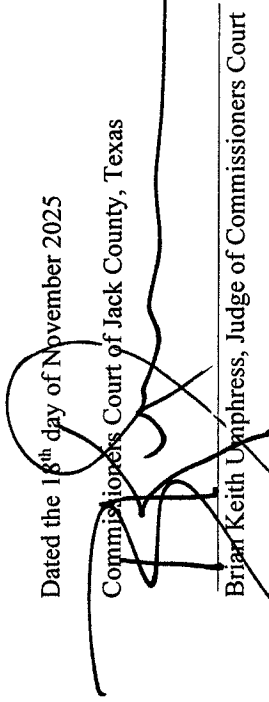

 - (f) Acknowledge and approve the engagement letter with MWH Group CPA Consultants;

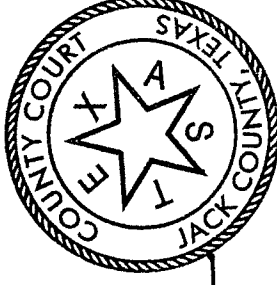

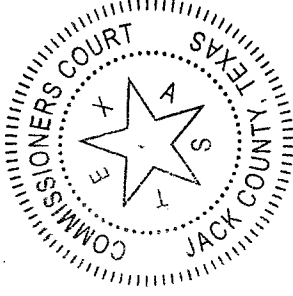
