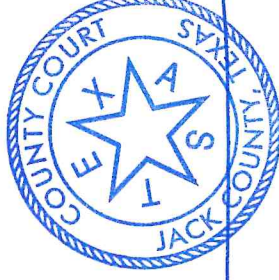

 - (e) Authorization of issuance of County Credit Card through TIB to Chris Reger in the amount of \$1,500;

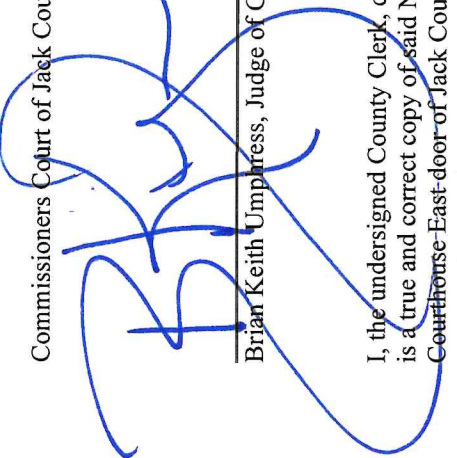

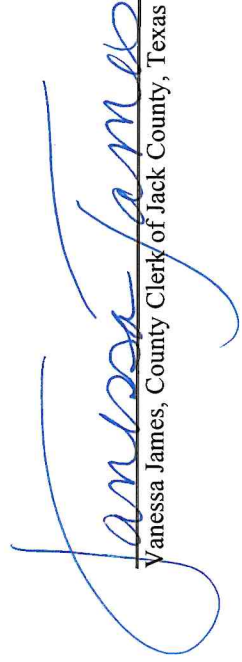




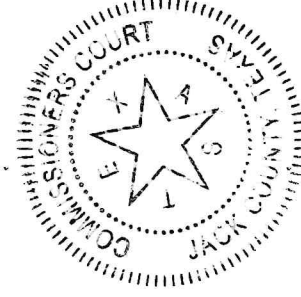
