THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT IS LOCATED ON LAND WITHIN THE JACK COUNTY PK SOLAR REINVESTMENT ZONE NUMBER 1 AND COMPRISES APPROXIMATELY 1,368 ACRES LOCATED IN SOUTHERN JACK COUNTY, WEST OF FARM TO MARKET ROAD 206.
