

CONSIDER AND TAKE APPROPRIATE ACTION ON A RESOLUTION AND ORDER AUTHORIZING THE COUNTY TO ENTER A TAX ABATEMENT AGREEMENT PURSUANT TO THE COUNTY'S GUIDELINES AND CRITERIA UNDER THE PROPERTY REDEVELOPMENT AND TAX ABATEMENT ACT, CHAPTER 312 OF THE TEXAS TAX CODE AS REQUESTED BY JACK COUNTY ENERGY STORAGE, LLC FOR APPROXIMATELY \$165,000,000 IN IMPROVEMENTS RELATED TO THE STORAGE OF ELECTRICITY UTILIZING BATTERIES. THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT IS LOCATED ON LAND WITHIN THE JACK COUNTY PK SOLAR REINVESTMENT ZONE NUMBER 1 AND COMPRISES APPROXIMATELY 1,368 ACRES LOCATED IN SOUTHERN JACK COUNTY, WEST OF SOUTH FARM TO MARKET ROAD NUMBER 4.
