THE PROPERTY SUBJECT TO THE ABATEMENT AGREEMENT IS LOCATED ON LAND WITHIN THE JACK COUNTY C1 JACK 1 REINVESTMENT ZONE NUMBER 1 AND COMPRISES AN APPROXIMATE RANGE OF 485 TO 940 ACRES LOCATED IN SOUTHEASTERN JACK COUNTY, SOUTH OF TEXAS STATE HIGHWAY 199.
