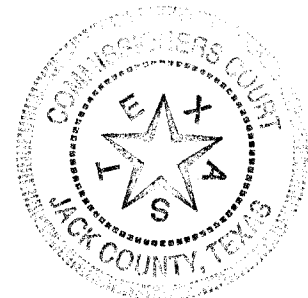


The Commissioners Court continues to work on the Budget for FY14. Sheriff Mayo continued working with the Court on his budget.


ADJOURN


