

THE STATE OF TEXAS COUNTY OF JACK

NOW COMES - Brigadier Operating LLC, hereinafter called Company, and respectfully makes this application to the Commissioners Court of Jack County, Texas, to grant unto the Company authorization to lay a pipeline or place a utility across and under the public roads of the County of Jack, State of Texas, conditioned as follows:

1. That said Company, in consideration for the grant by said County, does hereby agree that said pipeline/utility of the following description, crossing a county road in Precinct - _ _ _ _ Jack County, Texas, at a point hereinafter indicated, will be constructed in such a manner that the construction of same will not interfere with public travel, and that no construction will begin until the Commissioner of said precinct, his agents, or employee approves said location by an on-site inspection.

DESCRIPTION AND LOCATION (Map must be attached. Aerial photos are not acceptable. Location should include GPS coordinates of crossing.):

Dig across Martin Rd. at 33° 18' 55, 16"N

98° 16' 16.61"W

- 2. The Company assures the County that it has obtained authorization, if any is required, from any landowners adjoining the crossing to cross whatever portion of their land, if any, lies beneath the roadway.
- 3. Such pipeline/utility shall be encased, so buried, covered, constructed and maintained as not to interfere with the use and occupancy of such roads by the public or the County. That a pipeline shall be buried to the depth of at least three (3) feet below the surface of the borrow ditch, that the pipeline/utility shall be situated no closer than three (3) feet from the edge of the roadway, and that the road will be restored at the time of construction to its original condition.
- 4. In the event it becomes necessary to build a Farm-to-Market Road or other road across such roads, it will become the duty of said the Company to adjust its pipeline with such construction without compensation from the County.
- 5. If said crossing is accomplished by crossing the traveled portion of said road, then the Company agrees it shall, that at its expense, bore under the road as its means of crossing and not cut or trench said road for a crossing. Said boring shall be at a depth of at least three (3) feet below the depth of the borrow ditch.
- 6. The Company shall fill and level ditches using appropriate fill material or gravel so as to return the road and/or borrow ditch in same condition as before construction so far as possible. Company shall remove any large rocks unearthed at construction at its expense.


- 7. The Company shall pay, at the time of application, the sum of \$500.00 for each crossing unto the Treasurer of Jack County, Texas. In the event that the permit is not granted, the application fee will be returned.
- 8. Said access herein granted may be assigned by the Company without further grant or procedure but grantee shall be bound by the same conditions.
- 9. In the event that the Company abandons its line, the Company shall remove its line from the roadway and this grant is vacated.
- 10. The Company is responsible to present this application to the Commissioner of the Precinct involved and obtain his signature evidencing the fact that he has seen the application and discussed the location with the Company. The Company shall then present the Application with the appropriate check to the County Judge's Office to then make arrangements for placing the matter on the Commissioners Court Agenda for approval.
- 11. The Company shall call the County Commissioner 48 hours prior to starting the actual work.

CONTRACT FOR ASSESSMENT AND COLLECTION SERVICES

On this the 5th day of September, 2014, the County of Jack (hereinafter called "the County") and the **Graford Independent School District** (hereinafter called "the Taxing Unit"), enter into the following agreement, beginning on October 1, 2014 for a period of Three (3) years. This agreement will automatically renew every 3 year period, unless either party gives written notice of termination within 90 days of the expiration of the agreement.

PURPOSE

The parties to this agreement wish to consolidate the assessment and collection of property taxes in one agency of the Taxing Unit's parcels located in Jack County, Texas: Jack County Tax Assessor-Collector (hereinafter called "the JCTAC") and the Taxing Unit enters this agreement to eliminate the duplication of services and to promote governmental efficiency.

This agreement will only apply to the collection of taxes in regard to those parcels of property that are located in Jack County.

The parties enter this agreement pursuant to the authority granted by Section 6.24, Texas Property Tax Code, and Chapter 791, Texas Government Code.

SERVICES TO BE PERFORMED REGARDING THE TAXING UNIT'S PARCELS

- (1) The County shall collect the taxes owing to the Taxing Unit for the years 2008 and forward. The County further agrees to perform for the Taxing Unit all the duties provided by the laws of the State of Texas for the collection of taxes for said Taxing Unit for the years 2008 and forward except those that may be retained herein.
- (2) The County shall perform all the functions in the definition section of this agreement. Specifically, the County agrees to prepare tax statements for each taxpayer. The County shall mail said tax statements to each taxpayer within the Taxing Unit.
- (3) The Taxing Unit hereby designates the County as its Tax Assessor-Collector for purposes of compliance with TEX.REV.CIV.STAT.ANN.ART.7244c (Vernon Supp. 1980). In addition the parties agree that the County shall perform all of the duties of the Tax Assessor-Collector of the Taxing Unit as set forth in Chapter 26, 31 and 33 of the Property Tax Code except those excluded herein.
- (4) The County shall issue tax certificates regarding properties in said Taxing Unit by the authority granted by Section 31.08, State Property Tax Code. Said fee for tax certificates to be retained by the County to cover the cost of this service.
- (5) Contrary to anything contained herein, the County will only perform services relative to those parcels of the Taxing Unit located in Jack County, will not provide services for prior years, will not provide services regarding collection of delinquent taxes prior to 2008 and

will not set the annual effective tax rate.

PAYMENT

- (1) The County has estimated its cost of assessing and collecting taxes for all participating taxing units for the period of this contract during the normal budgeting process. The estimate of the cost of assessing and collecting has been approved in the same manner as the rest of the budget.
- (2) Based upon budgeted estimates and methods set forth in paragraph (1) of this Section, the Taxing Unit agrees to pay the County one percent (1%) of the gross taxes collected for services rendered during the term of this agreement.

REMITTANCE OF COLLECTIONS

During the tax collection year, disbursements shall be made to the Taxing Unit on a monthly basis by the Tax Assessor-Collector.

LOCATION OF TAX OFFICE

The tax assessing and collecting office shall be located during the term of this agreement within the Courthouse of Jack County, Jacksboro, Texas as determined by the Commissioners Court.

ADMINISTRATIVE PROVISIONS

- (1) The County shall not be liable to the Taxing Unit for any failure to collect taxes nor shall the Tax Assessor-Collector be liable unless the failure to collect taxes results from some failure on his / her part to perform the duties imposed upon him / her by law and by this agreement.
- (2) A biennial audit of the County Tax Assessor-Collector's operations shall be made by an independent certified public accountant selected by the County. The costs and expenses related to such audit shall be carried as an item of expense in the budget of the County and paid from operational expense funds of the County. Reports and financial statements prepared by the independent auditor in accordance with generally accepted accounting principles shall be furnished directly to the Taxing Unit. Said certified audit shall contain an unqualified auditor's opinion and shall specifically contain an analysis of the methods used by the Tax Assessor-Collector.

DELINQUENT TAX COLLECTIONS

All delinquent tax collections and decisions relative to same shall remain under the exclusive authority of the Taxing Unit.

CANCELLATION

Either party may cancel this agreement by written notice delivered 90 days prior to the expiration of the agreement.

DEFINITIONS

For purpose of this agreement the terms "Assessment and Collections" shall include the following: calculation of tax, preparation of tax rolls, pro-ration of taxes, correction of clerical errors in tax rolls, collection of current liabilities and issuance of refunds.



GENERAL ORDER REGARDING DISBURSEMENTS FROM COUNTY ENERGY TRANSPORTATION REINVESTMENT ZONE INCREMENT FUND

SUMMARY

General cleaning and manual labor to be performed primarily in and around County Courthouse, Courthouse Annex and other County buildings as directed by Commissioner's Court. In addition to regular custodian/maintenance duties, this individual will help supervise work being performed in County buildings and assume the responsibilities of the Building Custodian in his/her absence.

SUPERVISION RECEIVED

Works under the general supervision of the Building Maintenance Superintendant/Commissioner's Court.

SUPERVISION EXERCISED

None except.

ESSENTIAL DUTIES AND RESPONSIBILITIES

To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. Duties include the following:

- 1. Assist in supervision of custodian personnel.
- 2. Perform minor maintenance, plumbing, electrical, air conditioning and painting.
- 3. General cleaning of buildings. Mopping, buffing, stripping and waxing of floors.
- 4. Insure security of buildings. This includes removal of ice and snow from walkway leading to buildings.
- 5. Work closely with all departments to insure a good workflow.
- custodian directed supervisor for personnel otherwise by or as Superintendant/Commissioners' Court.
- 7. This is a full-time position and is essential that the individual be at work during the hours of 6:00 a.m. to 3:00 p.m., Monday through Friday, excluding sanctioned holidays; schedule/approved vacation, or illness as stated in the guidelines of the employee manual.

- 8. Performs other related tasks as directed by Superintendant/Commissioners' Court.
- 9. Insure inspections on Elevators and Boiler is current.
- 10. Maintain chemicals levels and fluid levels on boiler. Perform minor repairs and maintenance on Boiler.
- 11. Replace gaskets as needed on boiler radiators. Repair and/or replace lines and fittings as needed to insure safe and proper operation of heating system.
- 12. Repair and replace gaskets, valves, fittings, faucets in restrooms, kitchen, break rooms and mop closets as needed.
- 13. Repair/replace door knobs, locks, window panes, air-conditioners, light fixtures and flooring as needed.
- 14. Maintain record of all required inspection and see that these are properly inspected.
- 15. Insure that drain areas around exterior of courthouse are properly cleaned to insure drains will work properly.
- 16. Mow, edge, trim trees, trim scrubs/hedges, and fertilize lawn. Weed flower beds.
- 17. General maintenance and repair on sprinkler system. Responsible for the operation of this system.
- 18. Insure courthouse flags are replaced as needed. Insure flags are raised and lowered as directed by County Judge.
- 19. Paint, stain, sand as needed to maintain appearance of wood, metal, masonry, sheetrock, etc.

 Note: The duties listed above are intended only as illustrations of the various types of work that may be performed. The omission of specific statements of duties does not exclude them from the position if the work is similar, related or a logical assignment to the position and is assigned by the supervisor.

MANDATORY QUALIFICATIONS:

EDUCATION and/or EXPERIENCE

High school diploma or general education degree (GED). Individual must possess working knowledge of heating, plumbing, electrical, air conditioning, emergency generators, and custodial procedures and practices. One (1) to two (2) years of maintenance operations.

Other specialized job requirements include a valid Texas driver's license. Must be insurable by Comal County Insurance Company in order to operate County vehicles.

LANGUAGE SKILLS

MATHEMATICAL SKILLS

Ability to add and subtract two digit numbers and to multiply and divide with 10's and 100's. Ability to perform these operations using units of American money and weight measurement, volume, and distance.

REASONING ABILITY

Ability to apply commonsense understanding to carry out simple one- or two-step instructions. Ability to deal with standardized situations with only occasional or no variables.

In 2011, we incorporated a Heavy Equipment fund into our budget for FY12 under and arrangements were discussed in our budget workshops for that year whereby a portion of the Jack County Special Tax Rate (Road and Bridge Tax) was set and dedicated for the purpose purchasing heavy equipment under a rotation plan with the precincts.

We have purchased motor graders under the plan now for the last three years under that plan and disposed of some of the County's older motor graders. That plan is represented in the budgets then and since adopted by the Commissioners Court.

In light of recent budget workshops and discussions, I decided to research the minutes and visit the wording of this policy in preparation of our upcoming purchase and another motor grader under that plan.

In that search, I determined that the Minutes do not include that policy in written form. The Minutes contain one reference by way of the August 15, 2011 Agenda whereby the Commissioners would determine the rotation method for purchase of the graders in the event that "Precinct 5 (Heavy Equipment Fund) was adopted into the budget For FY12.

The Minutes do not include the arrangement, the results of the selection, or the details of the program.

I would propose to you in light of what I understand to have been the original agreement and in light of your practice since the plan has been set in motion the adoption of the following written policy for your Minutes:

Policy on Purchasing Items from Heavy Equipment Fund and Disposition of Surplus Motor Grader(s)

The informal rotation plan previously used in the purchase of motor graders from the Heavy Equipment Fund be formally adopted so that each year a motor grader in precinct order will by purchased out of said Fund per the annual budget adopted and ratify the action taken since FY12 under the original agreement and the grader purchases will be in numerical order which for FY15 will be Precinct 1.

Further under the initial terms of the plan, the Precinct benefiting that year will after the new purchase release the County's oldest motor grader in that Precinct for sale. Another Commissioner may opt to put that grader into service in his Precinct. In return, he will offer his oldest grader for sale. Ultimately, the proceeds of a grader sold annually under this arrangement shall be placed into the Heavy Equipment Fund for future purchases.



RESOLUTION TO ADD OPTIONAL WORKERS' COMPENSATION COVERAGE

WHEREAS <u>Jack County</u> has entered into a contract with Texas Association of Counties (TAC) for coverage of County personnel under the TAC Risk Management Pool, hereinafter called the Pool; and

WHEREAS the basic contract with the TAC Pool affords coverage for regular county employees, but provides for optional wider coverage by election of Commissioners' Court and

WHEREAS it is the desire and intent in Commissioners' Court that <u>Election Personnel, Jurors, and Volunteer Law Enforcement</u> be afforded coverage under the Pool;

THEREFORE, upon motion made by County Judge <u>Mitchell G. Davenport</u> and seconded by Commissioner <u>James L. Cozart</u>, the following order was adopted: <u>Election Personnel</u>, <u>Jurors</u>, and <u>Volunteer Law Enforcement</u> will be included for Workers' Compensation benefits under the County's contract with Texas Association of Counties Risk Management Pool.
