Judge Davenport presented a spreadsheet with bond requirements for those officials taking office on January 1, 2015.

A motion was made by Commissioner Cozart to increase the Bond amount by \$5,000 for Treasurer Kim Gibby and leave all others renewing at their current amounts. Commissioner Brock seconded and the motion carried unanimously.

LAW ENFORCEMENT CENTER (LEC) ROOF REPAIR PROJECT

Update Commissioners Court on status of L.E.C. Roof Repair Project, discuss repair options provided by Engineers, Insurance Adjusters, Roofing Contractors, and Consultants, prepare scope of work, time-line, and select contractor to perform work – Sheriff Mayo;

County Attorney Brad Dixon recommends to the Court that they accept the insurance check so the repairs can be made to the roof at the LEC. Further strategy may be necessary but should be discussed in Executive Session.

COUNTY ACCOUNTING SYSTEM UPGRADE
