





RE: City of Jacksboro Municipal Airport Improvements

Dear Judge Davenport:

The City of Jacksboro was recently awarded a capital improvement grant from the Texas Department of Transportation, Aviation Division, to make improvements on the airport runway. This is a multi-year grant, with engineering and design scheduled for 2016 and construction in 2017. We began the grant process in 2013, and at that time the Jacksboro Municipal Airport was eligible for federal funding for capital improvement projects. Since that time the Federal Aviation Association has changed the process for classifying municipal airports and the Jacksboro Airport is no longer eligible for those federal funds. As I am sure you can understand, once TXDoT Aviation Division lost the federally funded portion of the grant, then the entire scope of the project was significantly changed.

The initial project included a complete renovation of the runway, apron area and taxiway, with a total budget of almost \$2 million. In an effort to reduce costs, the project was subsequently changed from a renovation to a rehabilitation of the runway and apron. The rehabilitation plan includes filling any cracks on the surface and applying a slurry seal overlay on the entire runway. The estimated costs for the project has been reduced to approximately \$319,000.

I recently attended a meeting in Austin with the contractor, O'Malley Strand Associates, Inc., and engineers from TXDoT Aviation Division. Everyone is in agreement that the revised scope of work is insufficient to properly repair the airport runway. O'Malley Strand Associates has proposed an alternate plan with an estimated cost of \$629,000. We are exploring additional funding options as well as opportunities to lower the cost by having the City of Jacksboro perform some of the work. TXDoT Aviation Division also recommended we contact our District Engineer for the TXDoT Highway Division and discuss potential options for assistance from them.

This letter is intended to solicit support from you and the Jack County Commissioners in any discussions we have with TXDoT Highway Division. The City of Jacksboro is not requesting funding or material resources from Jack County. We are simply of the opinion that support from the Jack County Commissioners Court may enhance our chances of properly renovating the Jacksboro Municipal Airport and ensure we are able to maintain this valuable resource for our residents.

I thank you for your time and consideration, and look forward to the opportunity to discuss this matter in greater detail.
