

At a regular meeting of the Jack County Commissioners Court held at the Jack County Courthouse in Jacksboro, Texas, at which a quorum was present, the following order was adopted:

WHEREAS: Texas Election Code Title 6 Chapter 61 Section Subchapter A is titled General Provisions; and

**WHEREAS:** Section 61.003 is titled *Electioneering and Loitering Near Polling Place*; and

WHEREAS: Section 61.003 (a-1) allows an entity that owns or controls a public building to enact reasonable regulations concerning the time, place, and manner of electioneering; and

WHEREAS: Section 61.003 (b) (1) states "Electioneering" includes the posting, use, or distribution of political signs or literature;

**THEREFORE, LET IT BE ORDERED** that the Commissioners Court of Jack County enacts the following reasonable regulations, that will remain in effect until repealed, concerning the place and manner of electioneering:

- 1. No political signs may be posted, displayed or placed on any property that is owned or controlled by Jack County, Texas; and
- 2. Persons passing out political literature are permitted to electioneer on property that is owned or controlled by Jack County, Texas during the hours that the polls are open and if meeting all other requirements of Section 61.003.
