
These subjects may or may not be discussed in the order shown. All items listed below as part of



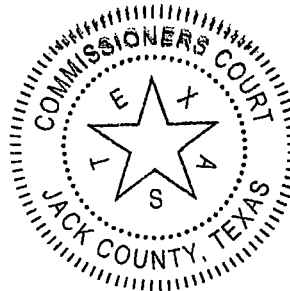

Judge Davenport made a motion to approve all claims and payroll submitted. Commissioner Ward seconded and the motion carried unanimously (3-0).






ADJOURNMENT

Meeting was adjourned at 8:34 a.m.




