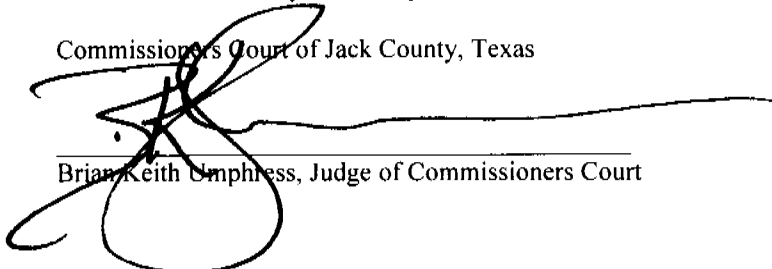

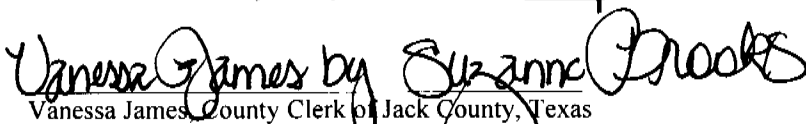

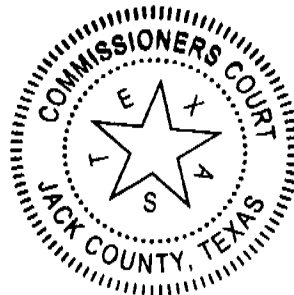

Lisa Perry reported that the Compressor refunds have begun going out.

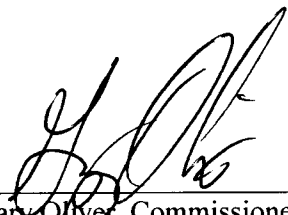

There being no further business motion was made by Commissioner Oliver to adjourn. Commissioner Ward seconded the motion to adjourn and the motion passed unanimously (3-0).

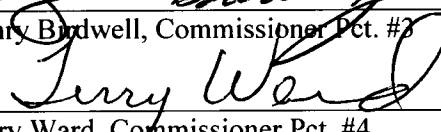

Gary Oliver, Commissioner Pct. #1

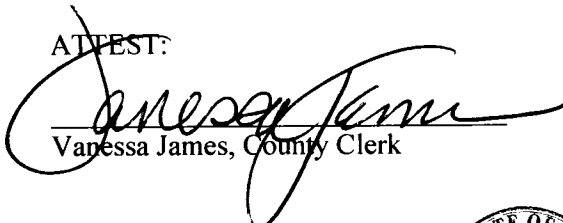


Henry Birdwell, Commissioner Pct. #3
