



ADJUSTMENTS IN PROPOSED BUDGET FOR FY2020 AND ADOPTION OF BUDGET

After reviewing and making final changes, Commissioner Ward made a motion to adopt the proposed budget with the changes made since the original filing. Commissioner Birdwell seconded and the motion was unanimous (5-0).

ADOPT TAX RATES TO FUND BUDGET FOR FY2020

- Rate Proposed in Filed budget:** \$0.548175 per \$100 of value
- Current Rate Proposed:** \$0.548175 per \$100 of value
- General Rate:** \$0.394240
- Interest & Sinking Rate:** \$0.040890

CONSIDER RATIFICATION OF THE AMOUNT OF PROPERTY TAXES COLLECTED FOR FY19 BE THE DECREASED/SAME/INCREASED OVER THOSE OF LAST YEAR AND BY THE ADOPTION OF THE PROPOSED TAX RATE

Commissioner Ward made a motion to ratify the action just taken to the effect that the amount of property taxes collected be increased by \$590,449.00 over those of last year by the adoption of a tax rate of \$0.548175 per \$100 of evaluation. Commissioner Oliver seconded and the motion was unanimous (5-0).
