NOW, THEREFORE, BE IT PROCLAIMED BY THE COMMISSIONER'S COURT OF JACK COUNTY, TEXAS:

- 1. That a state of disaster is declared for Jack County, Texas, pursuant to section 418.108(a) of the Texas Government Code.

- 3. That this proclamation shall take effect immediately from and after its issuance.
