### BUDGET FY 2020-2021 KICKOFF

The Judge will be providing the Commissioners with more budget information to prepare for budget meetings.

Commissioner Ward would like the plexiglass on the counters to be temporary.

They will begin painting on the 4<sup>th</sup> floor in the area where the IT Department will be moving.

Judge Umphress - Work continues on the outside doors for installation of new security features. Control of the doors will be web based. Individuals that work in the Courthouse will have a key FOB that will open doors and keypads on some of the doors. Offices have been given the option to have plexiglass installed on their counters to keep employees safe.

Sheriff Tom Spurlock reported one deputy unit received hail damage in the storm recently.




