PRESENTATION OF ANNUAL REPORT ON ACTIVITIES OF CONCERNED CITIZENS OF JACK COUNTY, INC. – RUSSONA JONES-BRISCOE

Ms. Briscoe thanked the Court for the CARES act and yearly budgeted funds allocated to them. They were able to give 5 days of frozen meals to their customers in case they are needed during bad weather. Making deliveries enables the elderly in the area to be able to stay home more during this time while Covid19 is prevalent.


