

COMMERCIAL PARTNERSHIP AGREEMENT

Partnership agreement proposed on 3/30/2021, between AIRFIBER LLC, of PO Box 962

Jacksboro, TX 76458 and The County of Jacksboro of 100 N Main St, Jacksboro, TX 76458. ("partners").

In consideration of the mutual promises contained in this agreement, partners agree as follows:

ARTICLE ONE. PURPOSE OF AGREEMENT

Partnership agreement outlines the exchange of fixed wireless broadband connectivity to be provided by AIRFIBER, LLC to the county of Jacksboro Texas in exchange for certain amenities provided by the county.

ARTICLE TWO. TERMS OF AGREEMENT

AIRFIBER, LLC responsible for the following:

- 50/50mbps fixed wireless broadband internet connectivity to the Jack County Courthouse located at 100 N Main St, Jacksboro, TX 76458 at no cost to the county
- 30/30mbps fixed wireless broadband internet connectivity to the Jack County sheriff's office located at 1432 FM 3344, Jacksboro, Texas 76458 at no cost to the county
- Provide consultancy services to the County of Jacksboro Texas to explore options on using RF spectrum reserved for state/county government

County of Jacksboro Texas responsible for the following:

- Consent for AIRFIBER, LLC to install & maintain telecommunications equipment on the roof of the
 Jack County Courthouse located at 100 N Main St, Jacksboro, TX 76458, including but not limited to:
 - Vertical asset (tower) not to extend beyond 15ft from the highest point of the building.
 Vertical asset to be anchored to structure of Courthouse.
 - o Wireless backhaul(s)
 - o Point to multi-point radios
 - o Directional antennas
 - o Battery backup(s) and/or power system(s). Power systems to be stored in elevator room on the roof of the Courthouse.
- Provide 30AMP 110VAC Power near AIRFIBER equipment
- Disallow any additional WISPs or providers of fixed wireless services to coexist on the roof of the Courthouse during valid period of this agreement.
- Facilitate coordination efforts between Cirra (provider currently operating RF equipment on the roof
 of the Courthouse) and AIRFIBER, LLC to ensure co-existence with minimal RF interference with one
 another.
- Grant 24/7/365 physical access of AIRFIBER equipment to authorized AIRFIBER and third-party personnel

ARTICLE THREE. DURATION & TERMINATION OF AGREEMENT

The term of this agreement shall be for three (3) years, commencing on mutual execution of this agreement and terminating three (3) years later unless sooner terminated by mutual consent of the parties or by operation of the provisions of this agreement.
