PRESENTATION BY LESLIE CHALMERS WITH JACKSBORO EDC

Leslie Chalmers, Director of the Jacksboro Economic Development Corporation made a presentation to the Court regarding their strategic plan for the community. Jobs, affordable housing, and downtown revitalization are the main goals. They would like to work together to get our downtown square filled with businesses and not empty buildings.
