Follow-up action required - Staff performing classification duties will obtain the required 4 hours of classification training. Administration will provide documentation of completed classification training to this inspector within 30 days.
273	Health Services	Reviewed a random selection of 7 files. Interviewed staff and inmates. Reviewed training records. Reviewed policy. Deficiency noted, see report - technical assistance provided - During the review of inmate medical files, it was observed that staff failed to notify the magistrate on multiple occasions when warranted by the CCQ return or affirmative answers on the Screening Form for Suicide and Medical/Mental/Developmental Impairments. Repeat issue - Technical assistance was provided during the FY21 annual inspection for failing to notify the magistrate when warranted. Follow-up action required - Administration will conduct documented training with staff within 30 days on the requirement of the magistrate being notified within 12 hrs when warranted by affirmative answers on the Screening Form for Suicide and Medical/Mental/Developmental Impairments or the CCQ return. Training documentation will be scanned and emailed to this inspector upon completion. Administration will also scan and email screening forms to this inspector weekly for the next 30 to 60 days for review.
273	Health Services (cont.)	Technical assistance provided - 1) During the review of inmate medical files, it was observed that staff are not completing the Screening Form for Suicide and Medical/Mental/Developmental Impairments in its entirety. Areas noted that were not completed include comments for affirmative answers, magistrate notification, medical notification, and mental health notification. 2) Staff failed to immediately notify a supervisor and/or medical when warranted by affirmative answers on the Screening Form for Suicide and Medical/Mental/Developmental Impairments. The required supervisor and/or medical notification was made up to three days after intake. Follow-up action required - Administration will conduct documented training within 30 days with staff on completing the screening form in its entirety and immediately notifying a supervisor and/or medical when warranted. Training documentation will be scanned and emailed to this inspector upon completion. Administration will also scan and email screening forms to this inspector weekly for the next 30 to 60 days for review.
