# SUBMISSION OF THE DECLARATION OF DISASTER FOR JACK COUNTY DATED MARCH 22, 2022 FOR COMMISSIONER'S COURT RECORDS

The day following the disaster a <u>Declaration</u> was signed by Judge Umphress. Motion was made by Commissioner Birdwell to submit the Declaration to the record. Motion was seconded by Commissioner Ward and passed unanimously. (5-0)

# DISCUSSION AND APPROVAL OF DISTRIBUTION OF FUNDS FROM "JACK COUNTY DISASTER RELIEF FUND" HELD AT JACKSBORO NATIONAL BANK BY RECOMMENDATION OF "DISASTER RELIEF FUND BOARD"

Auditor, Lisa Perry, would like for the board to have permission from the Court to spend the funds as needed.

Motion Birdwell made a motion authorizing the Jack County Disaster Relief Board to disperse funds from the Jack County Disaster Relief Fund as needed. Motion was seconded by Commissioner Oliver and passed unanimously. (5-0)

# REPORT FROM FRANK HEFNER, JACK COUNTY EMERGENCY MANAGEMENT COORDINATOR ON RECOVERY AND RESTORATION EFFORTS FOLLOWING THE MARCH 21, 2022 TORNADO DISASTER

Frank Hefner updated the Court regarding recovery. 314 properties were affected or destroyed, 284 of the structures were single-family homes, and 30 of them were businesses. Waste Connections is suppling 30 roll-off containers per week, vegetation debris is still being taken to the Sheriff's Posse Rodeo Grounds, TXDOT is working in town and the county to remove vegetation debris collection. Red Cross has ceased operations in town but is still available on a case-by-case basis. All other disaster groups have disassembled their operations. The resource center at the fair barn is scaling down its operations.

Charlie Martin, County Extension Agent, updated on the donations made to the County. Immediately he began to make a list of people willing to help and receive donations at the County Fair Barn. The Fair Barn was open 7 days a week after the disaster but has now is open Monday through Friday 8 a.m.-5 p.m. 438 families signed in to receive donations. There have been 334 volunteers who have logged 3,379.84 hours worked at the Fair Barn resorce center. The Jacksboro ISD Spanish Club attended Court today. They spent many hours volunteering at the Fair Barn organizing, making food, and helping hand out donations.

Will Mangum, Twin Lakes Activity Center, relief Center, and Red Cross was staged there, and several families that lost their homes came in for shelter. The Red Cross brought in cots, sheets, and blankets for the people there. Everyone has moved out of the activity center at this point. The community took in most of the people that were unable to stay in their homes.

Brandy Lacouture, TDEM disaster recovery task force, attended the meeting via zoom. Ms. Lacourture is working on a long-term recovery plan.

Lance Liggett, TDEM, Jack County has a success story because the community has turned out to help each other. It is amazing the amount of money that has been donated to help. FEMA is working on assessments, he and the EMC will be working on more information on the affected homes while FEMA still is analyzing the information.

# RATIFICATION OF ORDER LIFTING BURN BAN

Motion was made by Judge Umphress to ratify the <u>lifting of the burn ban</u>, however, if in the City limits residents will need to contact the City of Jacksboro before burning. Motion was seconded by Commissioner Salazar and passed unanimously. (5-0)

# UPDATE AND DISCUSSION REGARDING THE SAFETY AND HEALTH COMMITTEE MEETING HELD ON APRIL 6, 2022-KIM DUNGAN

The committee discussed possibly making a safety plan for the Courthouse for tornado or fire. The County Jail already has a standing emergency plan.

Michael Francis applied for an AED grant.

Wise Fire and Safety came and inspected the fire extinguishers in the Courthouse. They will be scheduling with the precinct barns to inspect theirs.

We have two active workers comp claims.
