DISCUSS AND APPROVE THE ELECTRICAL RIGHT OF WAY AND EASEMENT ON ROCK CREEK ROAD FOR JACK BARTON BESS LLC

Motion was made by Commissioner Birdwell to approve the Electrical Right of Way and <u>Easement</u> on Rock Creek Road with he and Judge Umphress continuing to work on the final agreement and giving the County Judge authority to sign. Motion was seconded by Commissioner Ward and passed unanimously. (5-0)

DISCUSS AND APPROVE FINANCIAL SUPPORT TO SEND MEMBERS OF THE JACK COUNTY CRISIS RESPONSE TEAM TO THE PALO DURO PRESBYTERY CRITICAL INCIDENT CHAPLAINCY TRAINING ON APRIL 26th, 27th and 28th, 2023, IN WICHITA FALLS, TEXAS

Motion was made by Commissioner Ward to approve financial support to send members of the Jack County Crisis Response Team to the Palo Duro Presbytery Critical Incident Chaplaincy Training and the cost to come from the general fund misc item. Motion was seconded by Commissioner Birdwell and passed unanimously. (5-0)

PRESENTATION, REVIEW AND CONSIDERATION OF CONSULTING AGREEMENT WITH HUB INTERNATIONAL REGARDING COUNTY HEALTH BENEFITS-BENEFITS ADVISORY COMMITTEE AND RODNEY DRYDEN

Rodney Dryden presented information to the Court regarding what HUB International has to offer the County for their employees.

Motion was made by Commissioner Birdwell to enter into an agreement with HUB International. Moton was seconded by Commissioner Oliver and passed unanimously. (5-0)

Motion by Salazar to be sold by auction via Purple Wave with Proceeds from roller and motor grader going to precinct 5. Motion was seconded by Commissioner Ward and passed unanimously. (5-0)

Motion to approve the purchase of a used roller through BuyBoard was made by Commissioner Salazar. Motion received no second.

Motion amended by Commissioner Salazar to purchase the new Sany Roller through BuyBoard. Motion was seconded by Judge Umphress and failed (3-2) Birdwell, Oliver, and Ward against.

Motion was made by Judge Umphress to enter into a contract for professional services with Allison, Bass, and Magee, L.L.P. regarding the Hecate Energy Dovetail Solar 1, 2 and 3, Hecate Energy Dovetail Storage, Hecate Energy Longhorn Solar and Hecate Energy Longhorn Storage. Motion was seconded by Commissioner Ward and passed unanimously. (5-0)

APPROVE AND SCHEDULE A PUBLIC HEARING IN APRIL FOR APPROVAL OF REINVESTMENT ZONE AND CONSIDERATION OF TAX ABATEMENT AGREEMENTS
