

ORDER CLOSING ROAD

Under the authority established by §§251.051, 251.052, and §251.058, Texas Transportation Code, the Commissioners Court of Jack County, hereby ORDERS and DECREES that in conformity with state law, a portion of roadway known as Walker Street between Guynn Ave. and Main Street and Gragg Ave, is hereby CLOSED to the public, and that public maintenance of said road shall cease immediately, and said road shall be omitted and deleted from any public map or other record reflecting roads maintained by Jack County, Texas.

IT IS FURTHER ORDERED THAT, under this Order, a portion of the undeveloped road previously known as Walker Street between Guynn Ave. and Main Street and Gragg Ave, more fully described as follows:

A tract of land located between Block 1 & Block 7 of the Orginal Townsite of Cundiff, Jack County, Texas filed September 14, 1892, in Volume 16, Page 576, Deed Records of Jack County, Texas;

IS BY THIS ORDER ABANDONED AND VACATED, and by this Order, title to the previous public road or portion of a public road that is closed, abandoned, and vacated by this Order, to the centerline of the road vests, on the date the order is signed by the County Judge in the owner of the property that abuts the portion of the road being closed, abandoned, and vacated. A copy of the order shall be filed in the deed records of the county and serves as the official instrument of conveyance from the county to the owner of the abutting property.


