DISCUSS AND APPROVE FINANCIAL PARTICIPATION IN THE PURCHASE OF A NEW DIGITAL MARQUEE IN FRONT OF THE JACK COUNTY COURTHOUSE

Motion was made by Judge Umphress to approve a contribution of \$11,000 toward the new marquee sign subject to agreeing on the contract to be presented at a later date. Motion was seconded by Commissioner Oliver and the motion passed unanimously. (4-1) Commissioner Ward voted against.

DISCUSSION AND APPROVAL OF AN ESCROW ACCOUNT TO BE SET UP AT JACKSBORO NATIONAL BANK PER SIGNED ROAD USE AGREEMENT WITH HECATE ENERGY LONGHORN SOLAR, LLC

Motion was made by Commissioner Birdwell to approve setting up an escrow account at Jacksboro National Bank in compliance with the Road Use Agreement with Hecate Energy Longhorn Solar, LLC. Motion was seconded by Commissioner Ward and passed unanimously. (5-0).

DISCUSS AND APPROVAL OF ACCEPTANCE OF FINAL PLAT FOR "ABEL'S PLACE SUBDIVISION", 148.191 ACRES IN THE H. MARTINEZ SURVEY, ABSTRACT #383 LOCATED IN PRECINCT #1, OFF COUNTY LINE ROAD, JACK COUNTY

Motion was made by Commissioner Oliver to approve and accept the final plat for "Abel's Place Subdivision". Motion was seconded by Commissioner Salazar and passed unanimously. (5-0)

DISCUSS AND APPROVE NAMING OF ROADS IN ABEL'S PLACE SUBDIVISION TO BE AS FOLLOWS: REUBEN LANE; VICKIE COURT; AND AARON COURT

Motion was made by Commissioner Oliver to approve the naming of roads in Abel's Place subdivision, Reuben Lane, Vickie Court, and Aaron Court. Motion was seconded by Commissioner Salazar and it passed unanimously. (5-0)

DISCUSSION AND APPROVAL OF ACCEPTING A BID FOR THE CONSTRUCTION OF NEW BUILDING FOR PRECINCT #2

Commissioner Salazar has received two bids, one from Norvill Construction and one from Craig Construction.

Motion was made by Commissioner Salazar to approve the bid for \$270,908 from Craig Construction for a building at Precinct 2. Motion was seconded by Commissioner Ward and the motion passed. (3-1) Commissioner Oliver opposed and Judge Umphress was called out for an inquest.

DISCUSSION AND ACTION REGARDING HOLIDAY TIME POLICY FOR JACK COUNTY SHERIFF'S OFFICE

Sheriff Hauger suggests the policy change to holiday pay must be used within the calendar year or be forfeited. He will adjust the current policy and present it to the Commissioner's Court for approval.
