PAYMENT OF ACCOUNTS AND CLAIMS

Judge Umphress made a motion to pay all accounts and claims submitted for approval. Motion was seconded by Commissioner Salazar and passed unanimously. (4-0) Commissioner Oliver abstained.

Tax Assessor/Collector Sharon Robinson gave her report for the month of April.

Judge Umphress made a motion to approve Consent Agenda Items. The motion was seconded by Commissioner Ward and passed unanimously. (5-0)

TIMED AGENDA ITEMS-10:15

10:16 a.m. Recognition of Deputy David VanderKaay of Jack County Sheriff's Office K-9 Unit efforts with criminal interdiction.

David VanderKaay was unavailable due to recent surgery. Judge Umphress recognized Deputy VanderKaay's efforts in a recent drug and stolen vehicle arrest.

Chris Reger informed the court of the incident that prompted this recognition. Dashcam video evidence was shown. The Commissioner's Court was also praised for approving the funding for equipment used in this incident. There have been 2 stolen vehicles confiscated recently due to the use of the license plate recognition system.

PRESENTATION OF "EXCELLENCE IN SAFETY AWARD" TO JACK COUNTY BY RISK MANAGEMENT CONSULTANT ERNESTO GALINDO

Mr. Galindo with TAC spoke to the court on the Safety award which was presented to Jack County for 2023 and congratulated the County for their hard work and efforts in achieving this award. Tammy Miller brought the plaque and banner to show the Commissioners.

PRESENTATION OF THE GALAXY DATA CENTER TOUR AND CONSIDERATION TO JOIN GLOBAL SITE LOCATION INDUSTRIES (GSLI) PROMOTION PROGRAM

Judge Umphress shared information about the BITCOIN mining operation program and CRYPTO currency and their visit to the facility in Spur, Texas. The County Judge would like for the Commissioner's Court to consider checking in to this and to work alongside the EDC. Frank Hefner presented a video.

Commissioner Birdwell would like to see a presentation, he is interested in anything that would lower the tax burden on the citizens of the County.

Mayor Craig Fenter would like to form a committee as soon as possible whether this avenue is pursued or not, for the growth of businesses in the county.

DISCUSSION AND POSSIBLE APPROVAL OF AN ESTIMATE TO PURCHASE AND REPLACE A 4-TON PACKAGE UNIT WITH INSTALLATION FOR THE LEC JAIL FROM RED LINE FOR THE ESTIMATED COST OF \$22,876.00

Scott Simonton reported to the court that he had tried to get more bids but was unsuccessful. He did ask Red Line to look at the cost of just repairing the unit which would cost around \$9,000 and would only have a 90-day warranty with this service. Red Line also adjusted the cost of the purchase of a 4-ton unit to \$20,326.

Motion was made by Commissioner Salazar to purchase the 4-ton unit for the adjusted cost of \$20,326.00. Commissioner Ward seconded and the motion passed (3-2).

Commissioner Birdwell will work alongside Scott Simonton to check on unit 7 repairs/replacement.

DISCUSSION AND APPROVAL OF "LOCAL RABIES CONTROL AUTHORITY" AND AN ALTERNATIVE FOR JACK COUNTY

Motion was made by Commissioner Birdwell to make the Jack County Animal Control Officer the Local Rabies Control Authority and a representative from Jack County Sheriff's Office as an alternative. Commissioner Salazar seconded and the motion passed (5-0).

Judge Umphress handed out budget packages to department heads. Budget workshop will begin next Commissioner Court meeting.

Deputy Scott Simonton gave updates on Purple Wave auction. Everything listed was sold.

Auditor Lisa Perry reported the outside audit is going well.

The Jack County Sheriff runoff election will take place at the end of the month and Sheriff office audits will need to take place.
