# DISCUSSION AND ACTION TO PROVIDE ASSISTANCE TO THE JACK COUNTY CLOTHES CLOSET

The County will assess the camera system the Clothes Closet currently has to see if it can be enhanced to get better quality video and pictures.

## DISCUSSION AND ACTION REGARDING THE FINAL STATUS AND PLACEMENT OF THE JACK COUNTY K9 UNIT

Motion Judge to accept the reimbursement from the former K-9 officer in the amount of \$6000 to purchase the K-9 unit. Commissioner Birdwell seconded the motion and it passed unanimously. (5-0)

CONSIDERATION AND ACTION FOR A BUDGET AMENDMENT TO FUND ADDITIONAL SCHOOL RESOURCE OFFICER (SRO) POSITIONS WITHIN JACK COUNTY SHERIFF'S OFFICE

Motion was made by Judge Umphress to approve making a budget amendment in the amount of \$36,750 to be funded from reserve funds to fund additional School Resource Officer positions within the Jack County Sheriff's Office. Motion was seconded by Commissioner Salazar, and it passed unanimously. (5-0)

## DISCUSSION AND POSSIBLE ACTION REGARDING THE PURCHASE OF ADDITIONAL JACK COUNTY SHERIFF'S OFFICE PATROL UNITS

Motion was made by Judge Umphress that we pay \$259,140 for the purchase of three Jack County Sheriff's Office School Resource Officer patrol units with funds from the reserve fund, and this will be a budget amendment for this FY2025. The Motion was seconded by Commissioner Salazar, and it passed unanimously. (5-0)

## CONSIDERATION AND ACTION FOR A BUDGET AMENDMENT TO FUND THE COUNTY'S PORTION OF 20% WORKER'S COMPENSATION SALARY WITHIN THE JACK COUNTY SHERIFF'S OFFICE

Judge Umphress made a motion to approve a budget amendment for \$5,376 to cover the County's portion of 25% of workers' compensation salary, for the rest of the fiscal year within the Jack County Sheriff's Office. Commissioner Oliver seconded the Motion and it passed unanimously.
