

ORDER OF APPOINTMENT FOR PRESIDING JUDGES AND ALTERNATE JUDGES


The Commissioners Court of Jack County does hereby appoint the following Election Judges for a two-year term beginning September 1, 2025 and ending August 31, 2027.





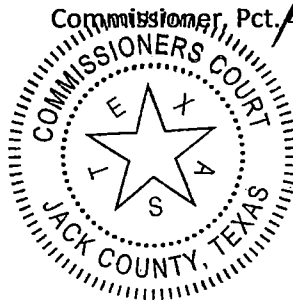
