RESOLUTION

A RESOLUTION OF THE JACK COUNTY COMMISSIONER'S COURT AFFIRMING THAT COUNTY FUNDS FOR THE JACK COUNTY SHERIFF'S OFFICE HAVE NOT BEEN AND WILL NOT BE REDUCED DUE TO RECEIPT OF SENATE BILL 8 IMMIGRATION ENFORCEMENT GRANT FUNDS

WHEREAS,

The Jack County Sheriff's Office provides essential law enforcement services to the residents of Jack County, Texas; and

WHEREAS,

The Texas Legislature, through **Senate Bill 8 (SB 8)**, established the **Immigration Enforcement Grant Program** to support local law enforcement agencies in enforcing state immigration laws; and

WHEREAS,

Jack County has received **Eighty Thousand Dollars (\$80,000.00)** in grant funding through the SB 8 Immigration Enforcement Grant Program for use by the Jack County Sheriff's Office; and

WHEREAS,

It is the intent of the Jack County Commissioner's Court that grant funds received under SB 8 **supplement and not supplant** existing county funding for the Sheriff's Office; and

WHEREAS,

The Jack County Commissioner's Court desires to formally affirm its commitment to maintaining county funding levels for the Jack County Sheriff's Office regardless of the receipt of SB 8 grant funds.

NOW, THEREFORE, BE IT RESOLVED BY THE JACK COUNTY COMMISSIONER'S COURT THAT:

1. Jack County **has not reduced** the amount of county funds budgeted or provided to the Jack County Sheriff's Office as a result of receiving SB 8 Immigration Enforcement Grant funds in the amount of \$80,000.00; and
2. Jack County **will not reduce** the amount of county funds provided to the Jack County Sheriff's Office in the future due to the receipt of SB 8 Immigration Enforcement Grant funds; and
3. All SB 8 grant funds received by Jack County are intended to **supplement existing Sheriff's Office resources** and enhance immigration enforcement efforts, and not to replace or offset county funding.
