HIGHLIGHTS

- 3 low-income student scholarships are awarded each year
 - Scholarship amount increased from \$1000.00 to \$2000.00
 - \$3000.00 scholarship payments in FY 2024
- There were 6 requests for financial assistance (food, rent/mortgage, utilities, etc.) totaling \$1864.00.
 - Requests for assistance are typically received through the Department of Family and Protective Services (DFPS) or the school districts.
- Each year DFPS caseworkers nominate foster family children for "Santa Wish List" Christmas gifts. 8 families were provided Christmas gifts totaling \$1354.00.
 - The dollar amount for each child (age range 0-3, 4-7, 8-12, 13-18) had not been increased for 7 years. The board voted to increase the dollar amount based on the current consumer price index of 2.9% at each age range.
- The board has not had to conduct direct mail fundraising since 2017. Yearly donations have been through the generous donations from the Jack County Commissioners, Prosperity Bank Community Development Grant Program, Jack County Probation Office and small yearly donors.

The only operating expenses are: yearly mailbox rental fee (\$88.00) and Jacksboro Chamber of Commerce dues (\$75.00).
